Examining Annual Targets for Indicator 2: Percent of youth with IEPs who exited special education due to dropping out

## November 2022

The Office of Special Education Programs (OSEP) at the U.S. Dept. of Education has released <u>each state's 2022 State Performance Plan (SPP) and Annual Performance Report (APR)</u> which includes new annual targets for results and compliance indicators 1-17 for years 2020 through 2025. Details are available <u>here</u>.

This special report examines each state's annual targets for the SPP/APR Indicator 2, which measures the percentage of students with IEPs who exited special education due to dropping out.

Below are the state targets for Indicator 2. As directed by OSEP, the state's <u>2025 target must reflect improvement over the baseline data</u>. The amount of improvement varies dramatically across states.

Some states have established targets that reflect only minimal improvement in the drop out rate over 6 years (AR, CT, IL, MS, NC, NJ, NY, PA) while other states have established targets that reflect very substantial improvement (CA, DC, HI, LA, OH, RI, SD, TX).

Kansas, Maryland and Michigan are excluded from this report because these states did not set targets using the calculation that must be used by all states beginning with the SPP/APR to be submitted in February 2023.



Indicator 2 Targets for FFY 2025

Percent of youth with IEPs who exited special education due to dropping out.



Drop out targets for 2025 range from a low of 3.17% in West Virginia to a high of 32% in the District of Columbia.
