Examining Annual Targets for Indicator 3D: Gap in proficiency rates for children with IEPs and all students against grade level academic achievement standards

October 2022

The Office of Special Education Programs (OSEP) at the U.S. Dept. of Education has released <u>each state's 2022 State Performance Plan (SPP) and Annual Performance Report (APR)</u> which includes new annual targets for results and compliance indicators 1-17 for 6 years (2020 through 2025). Details are available here.

This special report examines each state's annual targets for the SPP Indicator 3D which measures the gap in proficiency rates for children with IEPs and all students against grade level academic achievement standards.¹ This indicator is new for the 2020 APR.

Below are the state targets for Indicator 3D. As directed by OSEP, the state's 2025 target must reflect improvement over the baseline data. The baseline data is 2020 unless noted. The number of students served under IDEA in 2020-2021 is also reported along with the state's percent of total enrollment served under IDEA.

The amount of gap closing varies dramatically across states. Some states established targets that reflect only minimal gap closing over 6 years (AZ, CO, KS, MT, NJ, NM, NY, RI, UT) while other states established targets that reflect very substantial gap closing (AL, CA, CT, DE, MI, MS, NH, NC, WA).

¹ Proficiency rate gap = proficiency rate for children with IEPs scoring at or above proficient against grade level academic achievement standards for the 2020-2021 school year subtracted from the (proficiency rate for all students scoring at or above proficient against grade level academic achievement standards for the 2020-2021 school year.
